- ** Applicants applying for the Category 8d exam must have either a Bachelor's Degree with at least 12 hours in Entomology (include college transcript) or have at least four years experience working in an established mosquito control program (include a notarized affidavit of work experience).
- *** Demonstration & Research exams are given in Categories 1 through 8a. Applicants must also check at least one additional category; for example, 10 and 1. These count as two exams.
- **** Applicants applying for the Category 11 exam must also check at least one additional category; for example, 11 and 1. These count as two exams. In addition, applicants must also view a drift minimization video in Baton Rouge.
