The purpose of the report is (1) to provide a guide for private timber owners in determining stumpage prices regionally or statewide, (2) establish annual stumpage price figures for severance tax purposes and (3) determine the timber value for use-value assessment of forest land.

2013 FIRST QUARTER MARKET SUMMARY

Stumpage prices paid for pine sawtimber during the first quarter of 2013 averaged \$246.24 per thousand board feet Doyle. This average represents a 3.85 percent increase from the previous quarter and 4.29 percent increase compared to a year ago. Prices paid for mixed hardwood sawtimber during the first quarter of 2013 averaged \$408.55 per thousand board feet Doyle which is a 1.98 percent decrease from the previous quarter and 18.21 percent higher than a year ago. Pulpwood stumpage prices averaged \$23.79 per standard cord for pine and \$23.95 per standard cord for hardwood.
