The purpose of the report is (1) to provide a guide for private timber owners in determining stumpage prices regionally or statewide, (2) establish annual stumpage price figures for severance tax purposes and (3) determine the timber value for use-value assessment of forest land.

### 2013 SECOND QUARTER MARKET SUMMARY

Stumpage prices paid for pine sawtimber during the second quarter of 2013 averaged \$245.08 per thousand board feet Doyle. This average represents a .47 percent decrease from the previous quarter and .58 percent increase compared to a year ago. Prices paid for mixed hardwood sawtimber during the second quarter of 2013 averaged \$383.20 per thousand board feet Doyle which is a 6.20 percent decrease from the previous quarter and 20.5 percent higher than a year ago. Pulpwood stumpage prices averaged \$21.58 per standard cord for pine and \$21.33 per standard cord for hardwood.
