Prices reflect total volume and total value ratios paid from bid and negotiated sales. Values do not represent inter- or intra-company transactions and long-term contracts. The purpose of the report is (1) to provide a guide for private timber owners in determining stumpage prices regionally or statewide, (2) establish annual stumpage price figures for severance tax purposes and (3) determine the timber value for use-value assessment of forest land.

2015 FOURTH QUARTER MARKET SUMMARY

Stumpage prices paid for pine sawtimber during the fourth quarter of 2015 averaged \$264.48 per thousand board feet Doyle. This average represents a 8.57 percent increase from the previous quarter and .67 percent increase compared to a year ago. Prices paid for mixed hardwood sawtimber during the fourth quarter of 2015 averaged \$337.72 per thousand board feet Doyle which is a 2.92 percent decrease from the previous quarter and 24.00 percent lower than a year ago. Pulpwood stumpage prices averaged \$27.13 per standard cord for pine and \$30.44 per standard cord for hardwood.

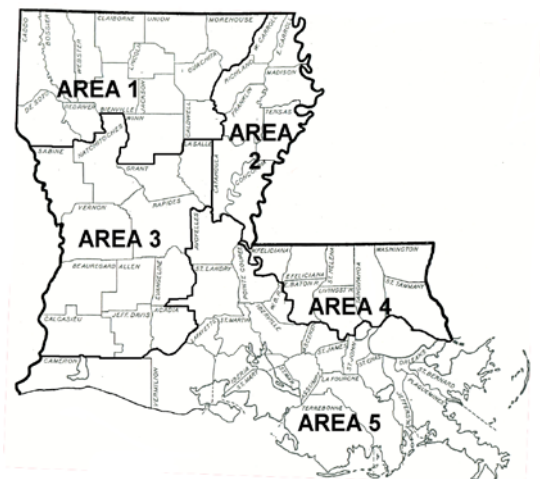
