LDAF Industrial Hemp Program Variety Designation List

This Variety Designation List is being provided as a resource for LDAF Industrial Hemp Program licensees. Licensees should review this list before purchasing or selling seed. This document provides guidance for licensees based on past ‘total’ THC test results from official LDAF samples of varieties or strains produced in Louisiana. The varieties or strains listed below are designated as *Not yet tested*, *Non-designated*, *Variety of Concern* and *Prohibited*. Only varieties or strains of hemp listed as “Approved” in the list below may be exempt from the requirements of LAC 7:XIII.1321(A).

Variety Designations

- **Not yet tested** – Variety or strain that has not been tested in Louisiana. Seed of this variety must be entered into the LDAF Industrial Hemp Program through the seed acquisition and approval process.
- **Approved** – Variety or strain that has been extensively tested over a multi-year period in Louisiana and test results have consistently shown the variety at a compliant THC level. Varieties or strains with this designation may be exempted from the seed acquisition requirements in LAC 7:XIII.1321(A).
- **Non-designated** – Variety or strain that has been tested in Louisiana and test results have shown the variety to be at a compliant THC level. Varieties or strains designated as Non-designated must be entered into the LDAF Industrial Hemp Program through the seed acquisition process.
- **Variety of concern** – Variety or strain that has at least one official LDAF sample test result above 0.30% total THC concentration level. These varieties are at a higher risk for exceeding the total THC limit. Although allowed in the program, growers should use caution when considering planting these varieties. Varieties or strains designated as *Variety of Concern* must be entered into the LDAF Industrial Hemp Program through the seed acquisition process.
- **Prohibited** – Variety or strain that is prohibited from being entering the LDAF Industrial Hemp Program. *Prohibited* designation is based on the following:
 - more than fifty percent of official LDAF sample test results exceed the 0.30% total THC concentration.
 - an official LDAF sample test result that is greater than 1.0% total THC
 - publicly available information that supports the fact that the variety or strain is marijuana.

Variety Designation List

This list is updated quarterly as new varieties are entered into the program and as official THC test results are available. Revision 21 MARCH 2022.
