Minutes

NOTE: This is a draft of the minutes from the March 14, 2023 meeting of the Industrial Hemp Promotion and Research Advisory Board. A final version of these minutes will be made available after approval of the board at the next regularly scheduled meeting.

CALL TO ORDER

The meeting was called to order at 9:30 a.m. by Chairman Representative C. Travis Johnson.

ROLL CALL

The roll was called by Ms. Erica Morse.

PUBLIC COMMENTS

There were no comments from members of the public made at this time.

APPROVAL OF MINUTES

The minutes of the November 15, 2022 meeting were distributed to the board members. Mr. Matthew Moreau made a motion to approve the meeting minutes. The motion was seconded by Mr. Blaine Jennings. The motion to approve the minutes passed unanimously.

MANDATORY SEXUAL HARASSMENT AND ETHICS TRAINING

Ms. Paeton Burkett reminded the board members of the mandatory annual Ethics and Sexual Harassment training that should be completed before the end of 2023.

INDUSTRIAL HEMP PROGRAM UPDATE

LDAF Administrative Program Coordinator Brent Cutrer provided an update on the Louisiana Industrial Hemp Program.

OLD BUSINESS

The board members were provided a copy of the statutorily required annual legislative report. LDAF staff informed the board that the report was submitted to the legislature prior to the January 31 deadline.

NEW BUSINESS

Procedural Note:

Chairman Representative Travis Johnson left the meeting at 10:15 a.m. A quorum remained with more than eight members of the Board still present.

Board member Laura Shivers left the meeting at 11:15 a.m. A quorum remained with more than eight members of the Board still present.

a. Industrial Hemp Seed Discussion

LDAF Seed Programs Director Lester Cannon provided an informational update on hemp seed quality and seed certification standards.

b. Fiber Plot Research Discussion

Mr. Brian Bolyer, hemp seed producer and founder of Okhish Mounds Farms provided an update on his fiber research plans and ideas.

c. **Discussion on Vidalia Mills blending hemp and cotton for textiles**

Mr. James Davis, Jr., hemp seed producer, provided information on Vidalia Mills Company expressing interest for 'cottonized' hemp to be used for blending with cotton for fabric instead of using synthetic polyester fibers.

d. **Industrial Hemp Building Material Discussion**

Tom Pires, a hemp grower from California and representing Western Fiber, provided information on his experience with California's Hemp Advisory Board and his hemp cultivation struggles and triumphs.

Mr. John Ford informed the board that he used hemp frames and flooring from Kentucky in his business located in Mississippi. He also reminded the board that hemp can be used for concrete, plywood, insulation, and biofuel.

e. **Discussion on grant opportunities from USDA**

Mr. Arthur Walker stated he found about 6-8 hemp grant opportunities from the USDA that the board needs to look at and pursue.

f. **Discussion on increasing LSU, SU, and ULM hemp educational information to the general public**

It was discussed by the board that by law, only three universities are permitted to work with industrial hemp: LSU, SU, and ULM. Dr. Reeve Legendre stated one of LSU's goals is extension work and research. He mentioned that Louisiana has a state mandated hemp industry central website. The website can be found at www.lahemp.net.

Lester Cannon stated that LDAF has a public relations team and there is a Boards and Commission's page on LDAF's website. He suggested the board send the information to LDAF and LDAF will add it to the page and other resources in attempts to share the information.

g. **Discussion of development of a hemp promotion and education plan and solicitation of funding for the plan**

The board discussed the issue. Dr. Janana Snowden further explained that SU meets regularly to discuss hemp education, curriculum, and research. She hopes they can secure additional funding to continue their research.

h. **Discussion of state laws across Louisiana affecting the hemp industry**

The board discussed the issue. Mr. John Ford further stated that our Louisiana legislators also need further clarification and education to help them in distinguishing between hemp and marijuana.

i. **Discussion of broadcasting board meetings and sub-committee meetings**

The board discussed the issue. Attorney Paeton Burkett informed the board that Zoom meetings are currently not permitted under state law. Under Open Meetings Law, the meetings can be held via Zoom only if there is a declared emergency in addition to meeting certain guidelines. She clarified that board meetings are in-person and open to the public.

j. **Discussion of tracking and informing board members of any legislation proposed to change the hemp industry or needs for legislative changes**

Mr. Arthur Walker stated that our state should track what surrounding states are doing in relation to industrial hemp and ensure that our laws are not hindering the production of industrial hemp in Louisiana.

Mr. Walker made a motion to add an agenda item k. “formation of a subcommittee for legislative education and public relations.” The motion was seconded by Mr. Matthew Moreau. The board voted unanimously to add item k. to the agenda.

k. **Formation of a subcommittee for legislative education and public relations**

Mr. Matthew Moreau made a motion to create a Legislative Education and Public Relations Subcommittee. The motion was seconded by Mr. Christopher Fontenot. The board voted unanimously to approve the formation of the subcommittee. It was decided by the board that the subcommittee should meet before the next statutorily required full board meeting. The subcommittee consists of the seven board members from the following groups: Louisiana Black Farmers Cannabis & Hemp Association, Morehouse Parish Black Farmers and Landowners Association, Louisiana Cannabis Association, LA Hemp Association, Louisiana Hemp Alliance, LSU AgCenter, and SU AgCenter.
